Criteria for Funding Camile Projects and Programs:

The purpose of the Camile Grant is to provide funding (in part) to special programs which address and deal with the **root causes of injustice, poverty and promote Christian growth**. All project and program applications are given consideration in the selection process, with the PSWR Church in Society Committee using the following criteria in the funding process:

- The proposed projects and programs must objectively demonstrate that they address the root causes of **injustice and poverty and promote Christian growth**.
- Previously funded projects and programs must demonstrate satisfactory accomplishment and progress towards the previous grant's goals and must submit financial records from the previous year's program.
- The total amount available for Camile projects and programs is determined by the annual distribution formula approved by the Regional Board. The annual percentage (5) is withdrawn from the permanently invested funds from the sale of the Camile Christian Church building. It was the wish of the congregation that this portion of their estate be used for "special projects and outreach."

Grant Procedures:

- All proposals, both new and continuing, are to be submitted to the Church in Society Committee before the published due date.
- Each section of the application must be completed in all grant proposals. Incomplete applications will not be considered.
- Financial and budget reports must accompany the grant application.
- All complete grant applications will be reviewed by the PSWR Church in Society Committee.
- Church in Society members will not participate in the decision-making process for the funding of any agency or program they represent.
- The Church in Society Committee will recommend grant amounts for proposed special projects and programs that best meet the stated criteria.
- The Church in Society Committee will respond in writing to all grant applications.
- All recommendations must be approved by the Board of Directors of the Christian Church (Disciples of Christ) Pacific Southwest Region.
- All applicants that receive Camile grant funding agree to provide the Church in Society Committee with captioned photos or a short video accompanied by a 75-word summary that briefly describes the project. Applicants must provide this information within 60 days after using the funding.

Application Procedures:

Each Camile Grant application must address the following questions and areas of information. Proposals are to be no longer than 2 pages plus supporting documents.

- What are the goals of the special project or program?
- Describe how progress toward achievement of the goals will be assessed (i.e. the numbers of program participants, interviews, surveys, feedback, etc.).
- Identify the target group, program participants, or population that will be served by the special project or program.
- Briefly describe how the project or program addresses and seeks to resolve the root causes of injustice and poverty.
- Describe Disciple (people and finance) involvement in the project or program.
- How are policy and decisions made which guide the project or program? Policy and decisions must demonstrate inclusiveness and equity. Include the names of persons on the governing body.
- Attach a proposed budget and current financial statement to your grant application.

Additional information needed for all projects or programs which previously received Camile grant funding:

- Identify progress toward accomplishments of identified goals.
- Did you provide Church in Society with captioned photos or a short video accompanied by a 75-word summary description of the project or program within 60 days of using previous grant funds? If so, to whom and when? If not, please explain.
- List the previous years this project or program received Camile grant funds and the amount received.

- Explique como el cumplimiento de los objetivos se puede medir (ej. numero de participantes, entrevistas, encuestas, etc.).
- Identifique el grupo, participantes del programa, o población la cual será servida por el proyecto.
- Brevemente explique como el proyecto/programa enfrenta las causas de las injusticia y la pobreza.
- Explique el involucramiento de Discipulos (de modo financiero y en persona) en el proyecto/programa.
- Explique como decisiones que guian el proyecto/programa que se hacen. Las decisiones acerca del programa deben de demostrar igualdad y participación inclusiva. Incluye las nombres de personas en la junta de gobernación.
- Adjunte un presupuesto de fondos y una declaración financiero actual.

Si la organización esta pidiendo fondos de Camile por una otra vez, más información es necesario:

- Identifique el progreso que se ha hecho acerca de las metas del proyecto/programa.
- Proporcionó a Church in Society fotos or video con una resumen del proyecto/programa dentro 60 días de las utilización de fondos de subvención? Si es así, a quien y cuando? Si no, favor explique.
- Favor de apuntar cada año y la cantidad que recibio de una beca Camile.
